

## Live Video Teller Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Live Video Teller ("Giveaway")

NO PURCHASE OR ACCOUNT OPENING IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE, OPENING AN ACCOUNT OR OBTAINING A LOAN WITH CCU WILL NOT INCREASE YOUR ODDS OF WINNING. PROMOTION IS VOID WHERE PROHIBITED BY LAW.

- I. Terms and Conditions - By entering the Promotion, you fully and unconditionally agree to abide by and accept these Official Rules. Failure to comply with these Official Rules may result in your disqualification from the Promotion.
- II. Eligibility - The Promotion is open only to legal residents of the United States, who, at the time of entering the Promotion are eighteen years of age or older. All entrants must be natural persons. No entries from business entities accepted. Employees of CCU, its affiliates, subsidiaries, advertising or promotional agencies, and their immediate family members and/or those living in same household are not eligible to enter the Promotion. Immediate family includes spouse, parents, siblings, children, stepparents, stepchildren, grandparents, grandchildren and volunteers. CCU reserves the right to verify eligibility qualifications of any winner. The value of each prize represents CCU's good faith determination of the maximum retail value thereof. For Form 1099 reporting purposes, each winner shall be bound by such good faith determination. By entering, entrants agree to comply with these Official Rules, including all eligibility requirements. Winning a prize is contingent upon fulfilling all requirements set forth in these Official Rules. Promotion Period - The Promotion begins on October 23<sup>rd</sup>, 2023 at 12:00 PM Eastern Standard Time (EST) and ends October 27<sup>th</sup>, 2023 at 3:00 PM Eastern Standard Time (EST) (the "Giveaway Period").
- III. How to Enter - No Purchase Necessary to Enter or Win. During the giveaway period, the Live Video Teller Leader will use the Wheel of Names" app online at <https://wheelofnames.com/> to enter all the tellers working the Live Video Tellers that day. The Wheel of Names will randomly spit out a Tellers name. The winning Teller will let their current member know that they have won the \$100 prize of the day. This will continue every day at designated

times through October 27<sup>th</sup>. You may also enter by filling out a piece of paper with your name and telephone number at our CCU table during event hours. Duplicate entries by text or paper entry will be disqualified. Entries must be received during the promotion period. If you wish to be removed from future sweepstakes, please email us at [mkting@cwcu.org](mailto:mkting@cwcu.org) and we will shred your paper entry form. If you wish to be removed from receiving future text messages, please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

- IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on October 23<sup>rd</sup>, 2023, at 12:00 PM (EST). The winner will be randomly chosen. The prize winner will receive \$100 deposited into their regular savings account. The prize is nontransferable and prize substitution will not be allowed.
- V. Publicity - Winner agrees to sign a public publicity release for CCU to use your name and likeness for editorial, advertising and publicity purposes without additional compensation, except where prohibited by law. By participating in this Promotion, all entrants' further consent to CCU's use of the personal information provided so that CCU may administer the promotion and award the prize.
