In 2023, Commonwealth Credit Union gifted Baptist Health Foundation Lexington a historic philanthropic gift to aid in the construction of Baptist Health Hamburg, which officially opened in April. Thanks to this facility, thousands of patients now have access to more convenient and comprehensive care. Commonwealth Credit Union's gifts to both Hamburg and now Richmond are transforming the landscape of healthcare in Central Kentucky, paving the way for advanced medical services and a brighter future for patients across the region.

The \$550,000 contribution will be allocated towards acquiring state-of-the-art high-fidelity simulation manikins and innovative technology. This effort aims to enhance the skills and expertise of clinicians by providing hands-on practice in a controlled, simulated setting. These simulations enable "safe mistakes," offering considerable benefits over traditional classroom learning and ultimately resulting in better patient care.

"This remarkable gift from Commonwealth Credit Union empowers our organization to offer simulation practice opportunities that rival those of larger teaching institutions. By providing access to advanced technology, we can enhance the competence, confidence, and clinical excellence of our entire healthcare team," said Mendy Blair, DNP, Vice President and Chief Nursing Officer at Baptist Health Richmond. "This is truly a dream come true for us, and we are profoundly grateful."

The donation will be used to acquire five high-fidelity simulation manikins, representing a variety of patients, from newborns to adults, including those in obstetric care. In addition, the simulation lab will be extensively upgraded to create a more dynamic and interactive learning environment. This initiative will also strengthen partnerships with local nursing schools, such as Eastern Kentucky University, Berea College, and Bluegrass Community & Technical College, further enriching the educational experience for nursing students

In recognition of this significant contribution, the newly renovated lab will be named the Commonwealth Credit Union Experiential Simulation Lab.

Greg D. Gerard, President of Baptist Health Richmond, praised the credit union's commitment: "Commonwealth Credit Union's generosity is truly inspiring. This is not Commonwealth Credit Union's first impact in the Richmond Community. Last spring, Commonwealth Credit Union donated a \$1 million gift to Eastern Kentucky University in support of the Evans Banking and Financial Services program and the establishment of a new certificate program in Financial Technology and Cybercrime. This certification was the first of its kind in the nation.
