

## Shelby Co. Vendor Fair: 3/18/25 Giveaway Promotion Rules

These are the Official Rules for Commonwealth Credit Union's ("CCU") Shelby Co. Vendor Fair: 3/18/25 ("Giveaway")

- IV. Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on March 19<sup>th</sup>, 2025 at 9:00 AM (EST) (Paper and Text to Win entries). The winner will be contacted via text message. The prize winner will receive a \$100 Visa gift card. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by March 26<sup>th</sup>, 2025 another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
  - V.
