

Old Forester's Paristown Hall – Dadi Freyr 8/2/2024 Giveaway Promotion Rules

If you wish to be removed from receiving future text messages please follow the directions on your phone. To be eligible individuals must be 18 years of age or older.

- Prize - The prize winner(s) will be selected by random drawing from all entries received during the Promotion Period on July 31st, 2024 at 10:00 AM (EST) (Paper and Text to Win entries). The winner will be contacted via email. The prize winner will receive four tickets to see Dadi Freyr at Old Forester's Paristown Hall on July 20th. If the winner cannot be contacted using the information provided with the entry, by telephone, or the prize is not claimed by July 31st, 2024 at 5:00 PM another winner will be drawn. The prize is nontransferable and prize substitution will not be allowed.
